This Reference Product comes from sites that have received ISO14001 certification.



### ■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780 km by road from our warehouse to the local point of distribution into the market Eurpe.

Packaging is compliant with with European directive 2004/12/EU concerning packaging and packaging waste and french decree 98-638 . At their end of life, its recyclability rate is 97 % (in % of packaging weight).

For the installation of the product, only standard tools are needed.

### END OF LIFE

The product end of life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse. This product falls within the scope of the WEEE directive (2012/19/EU). Therefore it must be processed through local WEEE recycling/recovery channels.

**• Extended producer responsibility:**

In France, the sale of products covered by the field of application of the European Directive on Waste Electronic and Electrical Equipment (WEEE) is subject to a contribution to a certified eco-organisation.

**• Recyclability rate:**

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 96 %. This value is based on data collected from a technological channel operating on an industrial basis. It does not pre-validate the effective use of this channel for the end of life of this product.
