




General information

Reference product	Altivar Soft Starter ATS490 170A 208 to 690V AC control supply 110 to 230V AC - ATS490C17Y
Description of the product	The main function of the Altivar Soft Starter product range is primarily to intend for the soft starting and breaking of the rotational speed of an asynchronous electric motor for heavy duty industry and pumps.
Description of the range	This PEP refer to a range of products assimilated to a reference product by an extrapolation rule. This range consists of products ATS490 with ratings from 140A to 170A for operation on 208 to 690V AC control supply 110 to 230V AC, 3-phase supplies IP20. The environmental impacts of this reference product are representative of the impacts of the other products of the range which are developed with a similar technology.
Functional unit	The aim of soft starter is to drive an asynchronous motor (squirrel cage) by limitation of the current during acceleration and deceleration phase with a torque control. It's based on three phases dimmer with Silicon controlled rectifier (thyristor). The rating of softstarter is given by nominal current 170A in the case study which lead to drive several power motor depending of power network voltage ie 230V power motor of 45kW and 690V power motor of 160kW. Calculation of the environmental impacts is based on 10 years of product service lifetime. The usage profile taken into account is 3,6% uptime in active phase, 46,4% uptime in stand by phase and 50% in control phase.
