



Description of the product	The main purpose of the Steel Floor-Standing Enclosures is to protect electrical equipment of low-voltage switchgear and control gear assemblies.
Functional unit	Protect persons during 20 years against direct contact with live parts and allow grouping monitoring, control and protection devices in a single enclosure with dimensions H2000mm x W800mm x D600mm, while protecting against mechanical impacts (IK10-IEC 62262) and the penetration of solid objects and liquids (IP55-IEC 60529) as per the standard IEC 62208.
