

Functional unit	To adapt the speed and torque of synchronous, asynchronous or reluctance motor to the machine's operating point for 90 kW electric motors for fluid management and industrial applications in IP55 conditions, at 380V to 480V rated 3-phase voltage supply. Calculation of the environmental impacts is based on 10 years of product service lifetime. The usage profile taken into account is 80% uptime in use phase at 75% loading rate and 20% uptime in stand by phase.
