


General information

Representative product	VW3E5001 SERCOS III cable - VW3E5001R030 - 3 meters
Description of the range	The VW3E5001 Feedback Cable range contains pre-assembled cables for the Modicon LMC078, the Pac Drive 3 offer and the Lexium 32S. This range consists of feedback cables with different lengths (from 9 cm to 99,5 m). The environmental impacts of this referenced product are representative of the impacts of the other products of the range which are developed with a similar technology.
Functional unit	To transmit data and signals on a distance of three meters during 10 years and a 100% use rate to control, measure and regulate equipments.


