





The Manufacturing phase is greatest impact on the Abiotic depletion (ADPe for EN15804), Net use of freshwater and also greatest impact on the Total Primary Energy on both manufacturing and use phase along with use phase is the life cycle phase which has the greatest impact on the majority of environmental indicators (based on compulsory indicators).
