


General information

Description of the product	The main function of the Capella Floorbox is to distribute electricity and VDI (Voice, Data, Image) to the end user in commercial buildings
Functional unit	Protect persons during 20 years against direct contact with live parts and allow grouping monitoring, control and protection devices in a single enclosure or a cabinet having the following dimensions 200 x 280 x 90 according to BS EN 60670-23:2008 standard, while protecting against the penetration of solid objects and liquids (IP20) in accordance with the standard IEC 60529.

Substance assessment

Products of this range are designed in conformity with the requirements of the RoHS directive (European Directive 2011/65/EU of 2 January 2013, amended in March 2015, 2015/863/EU and in November 2017, 2017/2102/EU) and do not contain, or only contain in the authorised proportions, lead, mercury, cadmium, hexavalent chromium or flame retardants (polybrominated biphenyls - PBB, polybrominated diphenyl ethers – PBDE), Bis (2-ethylhexyl)phthalate - DEHP, Benzyl butyl phthalate– BBP, Dibutyl phthalate - DBP, Diisobutyl phthalate - DIBP) as mentioned in the Directive.


