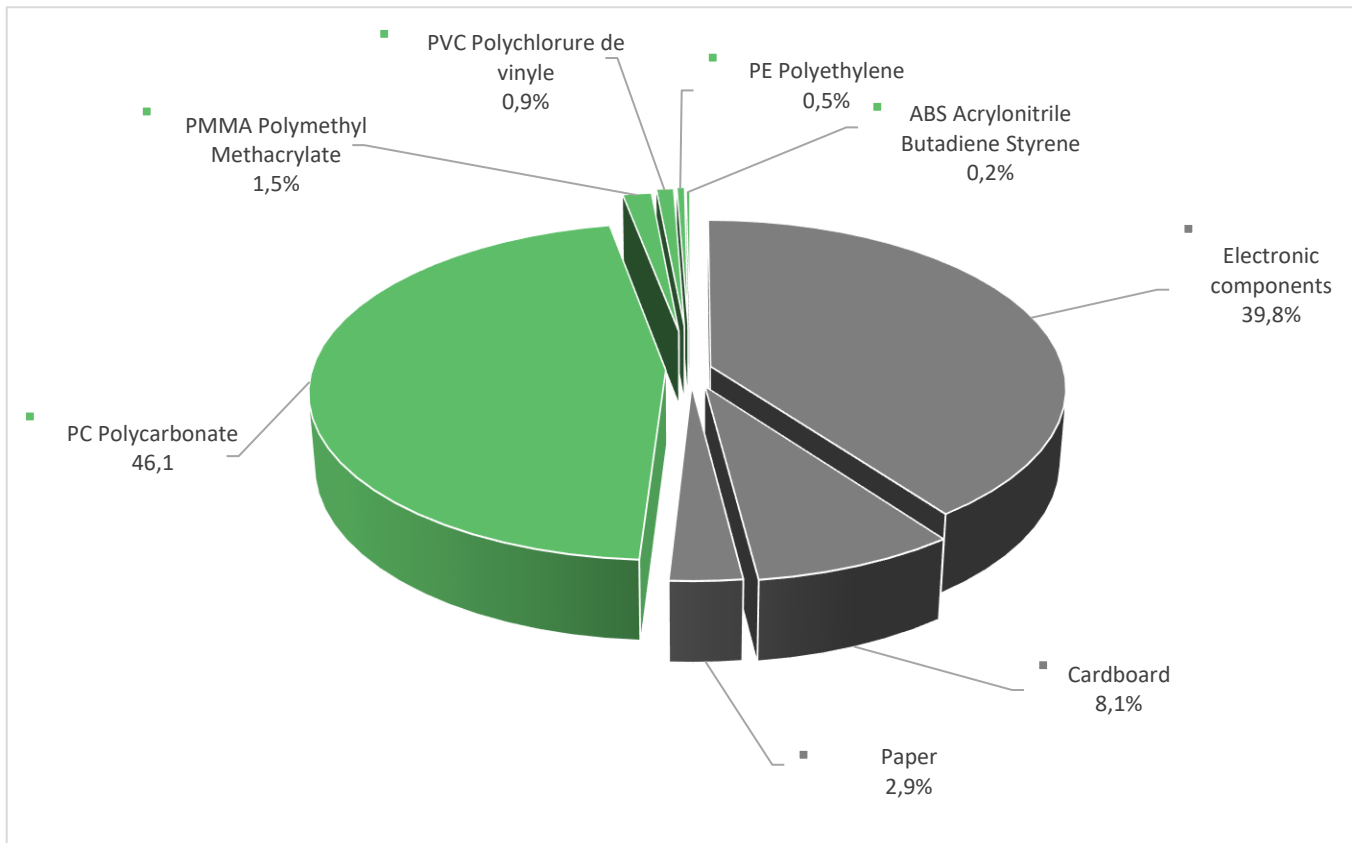

Description of the product	Maintained emergency luminaire (EN 60598-2-22) luminaire in which the emergency lighting lamps are energized at all times when normal or emergency lighting is required
Functional unit	Facilitate the evacuation of personnel by providing 8 lumens of light for five hours in the event of an electrical power cut and 45 lumens of light for one hour in the event of an electrical power cut with alarm This function is provided for ten years by its self-contained power supply

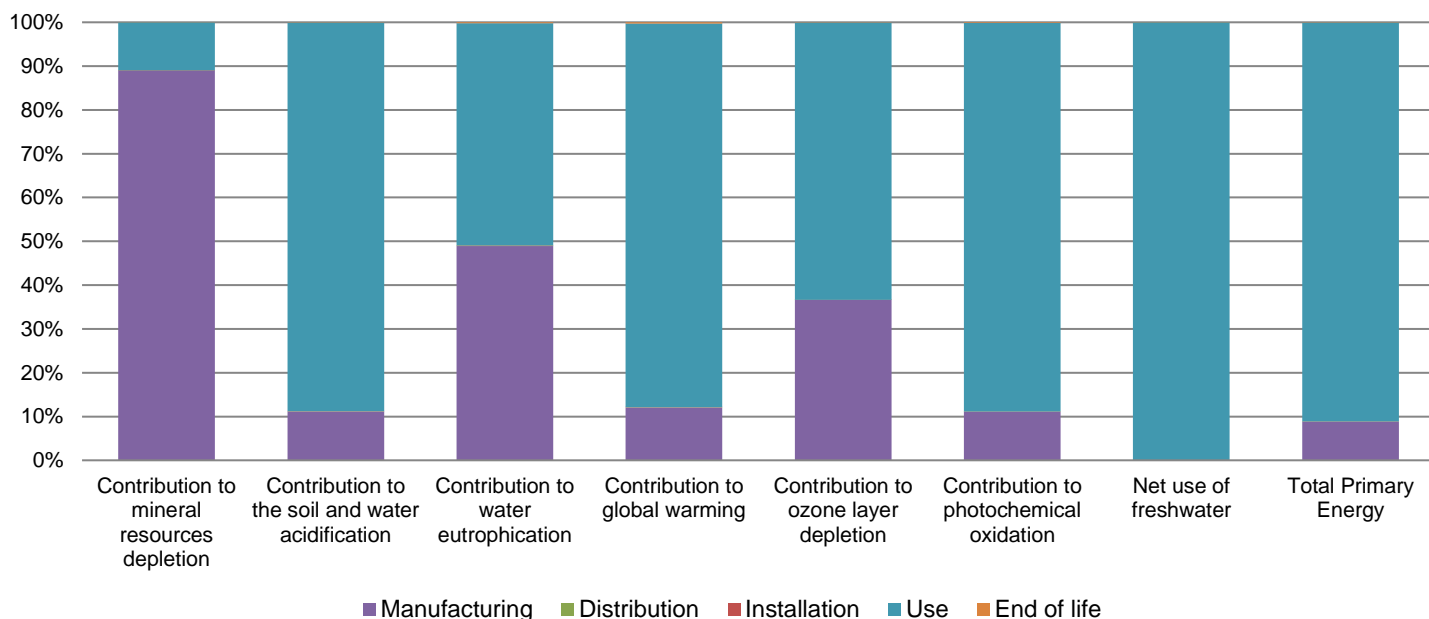

Design	The small capacity of the battery and the high efficiency of the LED light source reduce the energy consumption in the installation
Manufacturing	Manufactured at a Schneider Electric production site ISO14001 certified
Distribution	Weight and volume of the packaging optimized, based on the European Union's packaging directive Packaging weight is 70,3 g, consisting of Cardboard(90%) Paper (10%) Packaging recycled materials is 90% of total packaging mass. Product distribution optimised by setting up local distribution centres
Installation	Wall or ceiling installations needed
Use	During the product service life, a battery of 2x 22g should be changed 1 times to guarantee the rated discharge duration. The LEDs light source last 10 years or longer and doesn't need to be substituted.
End of life	End of life optimized to decrease the amount of waste and allow recovery of the product components and materials This product contains batteries: (2x 22g), electronic card: (50g) that should be separated from the stream of waste so as to optimize end-of-life treatment.
